Dear Chairman Fontaine and Members of the Planning Board:

Since the last major submission to the Planning Board in August, 2014, Silo Ridge Ventures, LLC ("SRV") has been working diligently with its development team to "fine-tune" the development plan for the project, and prepare written responses to Town consultants' comments, as well as public comments from the public hearing on the applications.
